

Transparency notification by Millennium International Management LP.

In accordance with article 14, § 1 of the law of 2 May 2007 on disclosure of major holdings, Millennium International Management LP has recently notified Umicore that it has crossed the statutory threshold of 3% for equivalent financial instruments downwards on 28 October 2024.

The total holding of direct voting rights and equivalent financial instruments of Millennium International Management LP now stands at 2.90%.
