11. GENERAL DESCRIPTION OF INFORMATION SECURITY MEASURES TO BE IMPLEMENTED BY THE RESPONSIBLE PARTY TO ENSURE THE CONFIDENTIALITY, INTEGRITY AND AVAILABILITY OF THE INFORMATION – Section 51(1)(c)(v)

The body has implemented the following Information Security Measures to ensure the confidentiality, integrity and availability of all information residing on its IT Systems and physical documents and copies in a locked office:

- Confidentiality of all information is accomplished by limiting authorised access on all information to specified personnel only. This is done by means of secure logins by employees only from the body managed devices. All backups of data are encrypted. The server physical access is limited to IT personnel only.
- Integrity is maintained with user access controls to limit all actions with data. The body has local and cloud backups that is fully encrypted. The backups can only be accessed by authorised personnel.
- The body operates a risk driven Information Security Management System (ISMS) consisting of policies, procedures, instruction and associated processes that are designed to maintain, review and continuously improve Information Security and compliance.
- Office access to physical documents is limited to authorised personnel only.





12. ACCESS TO THE RECORDS HELD BY THE PRIVATE BODY: THE REQUEST PROCEDURES

12.1 Form of request:

- 12.1.1 The requester must be given access to a record of a private body if the requester complies with the following:
 - 12.1.1.1 that record is required for the exercise of protection of any rights;
 - 12.1.1.2 the requester complies with the procedural requirements in the Act relating to a request for access to that record; and
 - 12.1.1.3 access to that record is not refused in terms of any ground for refusal contemplated in the Act.
- 12.1.2 The requester must use the prescribed form that has been printed in the Government Gazette [Govt. Notice R757 27 August 2021 Form 2 to this Regulation] to make the request for access to a record. This must be made to the head of the private body or the other person designated for this purpose, details of which are stated in paragraph 2 above. This request must be made to the address, fax number or electronic mail address of the private body [section 53(1)].
- 12.1.3 The requester must provide sufficient details on the request form to enable the head of the private body to identify the record in respect of which access is requested and the requester. The requester should also indicate which form of access is required and if any other manner is to be used to inform the requester, in which event the necessary particulars to be so informed, must be provided [section 53(2)(a) and (b) and (c)].
- 12.1.4 If, in addition to a written reply, the requester wishes to be informed of the decision on the request in any other manner, to state that manner and the necessary particulars to be so informed [section 53(2)(e)].



- 12.1.5 The requester must identify the right that is sought to be exercised or to be protected and provide an explanation of why the requested record is required for the exercise or protection of that right [section 53(2)(d)].
- 12.1.6 If a request is made on behalf of another person, the requester must submit proof of the capacity in which the requester is making the request to the satisfaction of the head of the private body [section 53(2)(f)].

12.2. **Fees:**

- 12.2.1. A requester who seeks access to a record containing personal information about the requester is not required to pay the request fee. Every other requester, who is not a personal requester, must pay the required request fee:
 - 12.2.1.1 The head of the private body must notify the requester (other than a personal requester) by notice, requiring the requester to pay the prescribed fee (if any) before further processing the request [section 54(1)].
 - 12.2.1.2 The fee that the requester must pay to a private body is R 100,00 plus VAT (if VAT is applicable). The requester may lodge a complaint to the Information Regulator or an application against the tender or payment of the request fee [section 54(3)(b)].
- 12.2.2 After the head of the private body has made a decision on the request, the requester must be notified in the required form.
- 12.2.3 If the request is granted, an access fee must be paid for the search, reproduction, preparation and for any time that has exceeded 6 (six) hours to search and prepare the record for disclosure [section 54(6)].

PART B: PROTECTION OF PERSONAL INFORMATION

14 INTRODUCTION

- 14.1 Words such as "we", "us" or "our" must be construed to mean Umicore Catalyst South Africa (Pty) Ltd.
- 14.2 We are committed to protecting personal information that is provided to us and respecting the right to privacy.
- 14.3 In accordance with the provisions of the Protection of Personal Information Act 4 of 2013 ("POPI"), we recognise the importance of transparency in how it intends utilising personal information.
- 14.4 This Privacy Policy applies to all information collected through our website and/or any related services, sales, marketing or events, employment advertisements, employment processes and improving business services.

15 **DEFINITIONS**

15.1 "Competent person" means a person who is legally competent to consent to any action.





- "Consent" means the voluntary, specific and informed expression of will in terms of which permission is given for the processing of personal information.
- 15.3 "Data subject" means a person to whom personal information relates.
- 15.4 "De-identify" means deleting any information that can be used to identify a data subject.
- 15.5 "Person" means a juristic or natural person.
- 15.6 "Processing" means any operation or activity or any set of operations, whether by automatic means, concerning personal information, including:
 - 15.6.1 Collection, receipt, recording, organization, collation, storage, updating or modification, retrieval, alteration, consultation or use;
 - 15.6.2 Dissemination by means of transmission, distribution or making available in any other form;
 - 15.6.3 Merging, linking, as well as restriction, degradation, erasure and destruction of information.
- 15.7 "Public body" means any department of state or administration in the national, provincial or local spheres of government and any other functionary exercising a power or exercising a duty in terms of the Constitution.
- 15.8 "Public record" means a record that is accessible in the public domain and it is in the possession of a public body.
- 15.9 "Responsible party" means a public or private person who, alone or in conjunction with others, determines the purpose of and means for processing personal information.



16 PURPOSE OF THE POLICY

16.1	POPI requires that personal information be collected for a specific, explicitly define	ec
and lav	vful purpose to a function or activity of the responsible person.	

16.2 This policy explains:

- (a) The purpose of collecting personal information.
- (b) What personal information is and how it will be collected.
- (c) Retaining and safeguarding processed personal information.
- (d) Disclosure of personal information to third parties.
- (e) What rights the data subject has which are associated with the information.
- (f) Storage of personal information.
- (g) Destruction of personal information.
- (h) Consenting to the processing of personal information.
- (i) Updates to this policy.
- (j) The name and address of the responsible party.
- (k) Where applicable, the responsible party intends to transfer the information to a third country or international organization and the level of protection afforded to the information by that third country or organization.



- (I) The necessary steps taken to make the data subject aware that collecting information is directly from the data subject.
- (m) Where reasonably possible, the steps taken after the information has already been collected to make the data subject aware of the collection.
- 16.3 This policy is not intended to supersede POPI, nor replace the provisions of POPI.

 Any provision in POPI not specifically referred to in this policy, will be considered incorporated in the policy.

17 PURPOSE OF COLLECTING INFORMATION

- 17.1 All personal information that is processed will be treated with the utmost confidentiality. Information will only be shared where such sharing is necessary.
- 17.2 Any further processing of personal information is done in accordance with the provisions of this policy.
- 17.3 Information may be used for the following reasons:
 - (a) To develop, provide and improve our products and services.
 - (b) To establish general demographics, statistics, or market information of website users.
 - (c) To identify an individual/employee, verification of such identity, create a user account and/or enter a contract with an individual.
 - (d) To provide a catalogue of new products and services from time to time.
 - (e) To obtain feedback from you on products.
 - (f) To recover any debt consumers may owe.





- (g) To tailor products and services, including marketing solutions, based on the information received.
- (h) We use the information that we collect about you to effectively run our business and to help us provide a pleasant, safe, and productive work environment for you.
- (i) Performing duties in terms of any agreement with you and other consumers.
- (j) Communicating with you by email, SMS, letter, telephone or in any other way about our products and services.
- (k) Process your personal information for ordinary business purposes (this includes opening and maintain your account, give effect to transactions, administer claims where applicable, manage our risks and maintain our overall relationship with you).
- (I) Carry out statistical and other analyses to identify potential markets and trends, evaluate and improve our business (this includes improving existing and developing new products and services).
- (m) Inform you about services and products available.
- (n) Payment of invoices.
- (o) Verifying information and performing checks.
- (p) Make sure our business suits your needs.
- (q) Comply with applicable regulations, and
- (r) Any other reasonably required purpose relating to our business.



17.4 We also use Personal Information to:

- a) Accurately process payroll
- b) Manage and plan our business
- c) Send out business mailings
- d) Conduct Employee reviews
- e) Handle disputes or grievances
- f) Manage Employee stocks
- g) Process any claims you bring
- h) For internal accounting
- Responding to queries received from the website, via email or social media platforms.

18 WHAT IS PERSONAL INFORMATION AND HOW IS IT COLLECTED

18.1 What is personal information? [section 1]

(a) It is any information that can be used to identify an individual. Such information may include name; address, contact number; email address including information pertaining to race; gender; sex; pregnancy; marital status; nationality; ethnic or social origin; colour; sexual orientation; age; physical or mental health; wellbeing; disability; religion; conscience; belief; culture; language and birth; education; criminal history; history of employment; personal views and opinions; other persons views and opinions.



18.2 How is personal information collected?

- (a) By visiting our website, our servers will automatically pick up, and provide us with the domain and IP address of the visitor.
- (b) If you decide not to provide us with your personal information, you may choose to deny the submission of personal information. Please note that denying submission of personal information may result in you not being able to use some services that may require submission of personal information.
- (c) Through engagement via social media platforms.
- (d) Through application for employment or while employed by us, as and when a need arises to update or obtain additional information.
- (e) When visiting our premises, all visitors are required to provide certain personal information before they enter our premises.
- (f) Any other personal information voluntarily provided through business dealings.
- (g) We also use certain monitoring and tracking technologies (such as cookies, beacons, pixels, tags and scripts). These technologies are used in order to maintain, provide and improve our services on an ongoing basis, and in order to provide our customers with a better experience.
- (h) Please note that third party services placing cookies or utilising other tracking technologies through our services may have their own policies regarding how they collect and store information. Such practices are not covered by our Privacy Notice and we do not have any control over them.



(i) Our website uses cookies, web beacons and similar technologies to track information provided to us by your browser when you use our website. Cookies are small text files containing small amounts of information which are downloaded and may be stored on any of your devices that enable internet usage.

19 WHAT PERSONAL INFORMATION IS COLLECTED

- 19.1 Gender, ethnic group, nationality, marital status, identity or passport number.
- 19.2 Date of birth.
- 19.3 General contact information, such as address, telephone number, and email.
- 19.4 Social Media profile information.
- 19.5 Details of payments to third parties.
- 19.6 Professional or personal references.
- 19.7 Company documents and forms completed by you.
- 19.8 Assessments, evaluations, performance reviews, training completion rates, and training scores.
- 19.9 Banking and financial information.
- 19.10 Browsing habits and click patterns on our websites.
- 19.11 Company information and directors' information.
- 19.12 Other personal details you voluntarily provide to us.





20 RETENTION OF PERSONAL INFORMATION

- 20.1 Personal information will be retained for a period reasonably necessary to fulfil the purposes of this Policy unless:
 - (a) A longer retention period is required or authorised by law.
 - (b) The responsible party requires the record for lawful purposes related to its functions or activities.
 - (c) The data subject consents to the retention.

21 DISCLOSURE OF PERSONAL INFORMATION

- 21.1 We will not share your information without consent, whether with internal stakeholders or outside third parties. **[section 20 (b)]**
- 21.2 Save for 17.1 above, personal information may be shared without your consent only in the following circumstances:
 - (a) If legally required to do so to comply with applicable laws, judicial proceedings, court order or legal proceedings. [section 18(4)(c)]
 - (b) If necessary, to take any legal action regarding potential or actual violations of our policies or the protection of our legal rights.
 - (c) In cases of buying and selling of assets, or merger's, acquisition, or a similar transaction.
 - (d) When such information is processed into non-personally identifiable information such as statistical data. [section 18 (4)(f)]
 - (e) Where it is necessary to protect people's life, body, or property.



- 21.3 In certain cases, we may have to disclose your Personal Information to third parties without your consent or prior knowledge. We limit that disclosure to the following circumstances:
 - (a) To satisfy any laws or regulations.
 - (b) To respond to requests, such as discovery, criminal, civil, or administrative process, subpoenas, court orders, or writs from law enforcement or other governmental or legal bodies.
 - (c) To bring legal action against an employee who has violated the law or policy.
 - (d) In the case of any business transfer, sale, or transfer of assets of the Company.
 - (e) If we suspect any fraudulent activity within or in relation to the Company, or if we have noticed any activity which may violate our ethics, guidelines, or other applicable rules.

22 YOUR RIGHTS

You have the right to:

- 22.1 Be informed that personal information is being collected. [section 18(1)(a)]
- 22.2 Be informed of the purpose for which the information is collected. **[section 18(1)(c)]**
- 22.3 Be informed of any law authorising the collection of information. [section 18(1)(f)]



- Be informed whether the supply of personal information is voluntary or mandatory. [section 18(1)(d)]
- 22.5 Be informed of the consequences of the failure to provide the information. [section 18(1)(e)]
- 22.6 Withdraw consent given to collect Information. [section 11 (2)(b)]
- 22.7 Request the erasing of data or information. [section 5(c)]
- 22.8 Request access to your personal information stored by us. [section 5(b)]
- 22.9 Request the responsible person to confirm whether your information is held by us. [section **23(1)(a)]**
- 22.10 Request from the responsible person to record or describe the nature of the personal information held by us.
- 22.11 To establish whether a responsible person holds personal information and to request that we transfer your personal information to yourself or a third party.
- 22.12 Request that we correct any information stored. [section 23(2)]
- 22.13 Object to the method we use to collect your personal information. **[section** 11(3)(a)]
- 22.14 Request that information collected is restricted. [section 14(6)(c)]
- 22.15 Request that your personal information not be processed for the purposes of direct marketing. [section 5(e)(i)]
- 22.16 Not be subjected to decisions solely based on automatic processing of personal information. [section 5(g)]





- 22.17 Submit or lodge a complaint to the Regulator regarding the alleged interference with the protection of the personal information of any person who supplied us with their personal information. [section 5(h)]
- 22.18 Institute civil proceedings regarding the alleged interference with the protection of personal information. [section 5(i)]
- 22.19 Request that we delete or erase any information about yourself. We will ensure that this request is complied with timeously. **[section 24]**

23 INFORMATION STORAGE AND SECURITY OF INFORMATION

- 23.1 We ensure to secure the integrity and confidentiality of personal information in its possession or under its control to prevent:
 - (a) Loss of or damage to or unauthorised destruction of personal information.[section 19 (1)(a)]
 - (b) Unlawful access to or processing of personal information. [section 19 (1)(b)]
 - (c) We only store your Personal Information for as long as it is necessary unless you request deletion of your Information.
 - (d) We may also store your Personal Information for any applicable legal record-keeping (e.g., maintaining our accountancy records or otherwise maintaining the safety and security of our Company, for a time period permitted by applicable law).



- (e) We employ organisational and technical security measures to protect your Personal Information, such as limiting access to your Personal Information, secured networks, and encryption.
- (f) We ensure that your Personal Information is protected against unauthorised access, disclosure, or destruction by utilising practices that are consistent with standards in the industry to protect your privacy.
- (g) Please note, however, that no system involving the transmission of information via the Internet or the electronic storage of Information is completely secure, no matter what reasonable security measures are taken.
- (h) Although we take the protection and storage of your Personal Information very seriously, and we take all reasonable steps to protect your Personal Information, we cannot be responsible for data breaches that occur outside of our reasonable control.
- (i) We will, however, follow all applicable laws in the event a data breach occurs, including taking reasonable measures to mitigate any harm, as well as notifying you of such breaches as soon as possible.

24 INFORMATION OFFICER

- 24.2 He ensures that there is compliance with any and all applicable legislation.
- 24.3 We undertake to:



- (a) Identify all reasonably foreseeable internal and external risks to personal information in its possession or under its control. [section 19 (2)(a)]
- (b) Ensure all personal information processed is secured against identified risks. [section 19 (2)(b)]
- (c) Regularly verify that safeguards are effectively implemented. [section 19(2)(c)]
- (d) Ensure safeguards are continually updated. [section 19 (2)(d)]

25 **DATA BREACHES**

We will notify you and the Regulator as soon as we become aware of any data breach that may result in a risk to your rights and freedoms.

26 DESTRUCTION OF DOCUMENTS

- 26.1 All documents containing personal information may be destroyed after the effluxion time as per required or authorised law.
- 26.2 All personal information will be destroyed, deleted or de-identified as soon as reasonably practicable, after there is no authorisation to retain the personal information. [section 14 (4)]
- 26.3 Destruction of the personal information will be in a manner which prevents reconstruction thereof in an intelligible form. [section 14 (5)]

27 CONSENT

27.1 All personal information processed is done in a lawful and reasonable manner which does not infringe the privacy of the data subject. **[section 9]**



- The information that is processed, given the purpose for which it is processed, must be relevant, adequate, and not excessive. **[section 10]**
- 27.3 All information processed is directly collected from the data subject unless: [section 12 (1)]
 - (a) The information is collected from a public record or source. [section 12(2)(a)]
 - (b) The data subject consents to collecting the information from another source. [section 12 (2)(b)]
 - (c) Collecting the information from another source does not prejudice the interests of the data subject. [section 12 (2)(c)]
 - (d) Collection from another source is necessary. [section 12 (2)(d)]
 - (e) Compliance would prejudice a lawful purpose for collection. [section 12 2(e)]
 - (f) Compliance is not reasonably practical. [section 12 (2)(f)]
- 27.4 We will only process personal information if:
 - (a) A data subject consents to the processing of information. [section 11 (1)(a)]
 - (b) Processing is necessary to carry out actions to conclude or perform in terms of a contract to which the data subject is a party. [section 11 (1)(b)]



- (c) Processing protects a legitimate interest of the data subject. [section 11(1)(d)]
- (d) Processing is necessary for the proper performance of a public law duty.
 [section 11 (1)(e)]
- (e) Processing is necessary for pursuing the legitimate interests. [section 11 (1)(f)]
- 27.5 By accessing our website, entering our premises, applying for employment or accepting a contract of employment, you consent to the use and collection of your personal information by us.
- 27.6 This policy may be amended from time to time. If there are major changes to this Policy, and such changes materially affect personal information stored, we will notify any person affected by the amendment, of such changes.
- 27.8 The continued use of the website after the updates or amendments have been made to this Policy has the effect of you agreeing to be bound by the new terms of the Privacy Policy.

28 UPDATES

- 28.1 The Company may update, change, remove, or add any portions to the policy from time to time.
- 28.2 When this occurs, an amended or updated version of this policy will be made available.
