Transparency notification by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on disclosure of major holdings BlackRock, Inc. has notified Umicore on 9 April 2019 that on 8 April 2019 it has crossed the statutory threshold of 3% downwards for equivalent financial instruments. In total (direct voting rights + equivalent financial instruments) Blackrock Inc. holds 6.43% of Umicore's shares and voting rights.
